- While applying, the students will be asked 2-4 questions in the application like 'Why you should be hired for this internship?', 'What is the duration for which you are available?' etc. After answering these questions, submit the application to the employer.
- If the students get shortlisted or selected for the internship, then the employer will get in touch within 2-3 weeks regarding further details on engagement.
